Your request for information

Thank you for your email of 11 December 2018 in which you requested disclosure of the following information:

I already know you have provided details for primary schools on 03.12.18 (but the date period does not include her full tenure).*
- 2. Could you also include teacher-led events (not conferences) that she has attended on a Saturday. For example, New Voices on 13th October 2018 and any other similar events.*

I would like this data broken down by:

- 1) OFSTED grading*
- 2) Type of school (including free school, grammar, studio etc)*
- 3) Region*
- 4) Date of visit*
- 5) Name of school/event*

We emailed you on 12 December to clarify the second part of your request, and you responded by amending it to be:

"Could you provide a breakdown of any conferences attended on a Saturday. Title of event and date."
