Thank you for your request for information, which was received on 16/05/2019. You requested the number of visits to early years, primary, secondary state schools, FE / HEI colleges and English independent schools (including education visits overseas) by Nick Gibb MP since 29th November 2018 to Wednesday 15th May 2019. Broken down by:

- 1) OFSTED grading
- 2) Type of school (including free school, grammar, studio etc)
- 3) Region
- 4) Date of visit
- 5) Name of school

I have dealt with your request under the Freedom of Information Act 2000. The majority of the schools the Minister visits are arranged as a result of an invitation. This data starts from 29/11/2018 and ends on 15/05/2019.

A copy of the information requested; 4) Date of visit and 5) Name of School is attached in the format requested.
